Categories and Methodology



PROVIDER CATEGORIES

Two elements make up the awards judging; the first is a financial adviser testimonial process that takes place between 29 January 2024 and 5 April 2024, whereby advisers nominate their top three providers across protection, retirement and investment products and services. Advisers are free to nominate any providers, rather than having to select from a predetermined list. These results are then given over to the analytical expertise of our research team, who will thoroughly examine each provider, their products and their activity during the preceding 12-month period to come to the final decisions. For the Innovation Award and Best Technology in the Investment Life & Pensions Sector, we also talked to advisors and providers via a number of routes, including self-submission and our annual adviser survey. The information provided ensures that we are aware of all instances in the industry where new initiatives or innovative offerings have been put into place, or where exceptional technology solutions have made a real difference to the industry.



ADVISER CATEGORIES

Throughout spring, entries are invited from advisers. We also consult our provider contacts for their thoughts on who should be considered. Advisers complete a questionnaire providing details of their organisation, their level of expertise and how they deliver their advice proposition and are asked to support this with evidence of their ability to deliver award-winning service. Based on submission quality, a shortlist is drawn up and announced in May. Shortlisted advisers can then invite testimonials (submitted via an online form) until late June 2024. An internal judging panel assesses these to decide upon the final positions.
